Minutes of Board Meeting Thursday, December 7, 2023

The meeting of the Linden–Peters Rural County Fire Protection District Board of Directors was called to order by President Paul Castillou, Jr. at 7:00 p.m.

(III.) Public Comment - Public comments were made concerning the training area located in the back of the Fire District's property. There was a public comment regarding the online posting requirements for the Board Meeting Agenda.

Board President Paul Castillou, Jr. thanked the public for the comments.
