Fire Chief Kirk Noffsinger provided an update on the events and meetings held for the month of July 2024 along with providing an overview of the calls, volunteer report, training, and FIU report. Captain Marcel Mojalli provided the Shift Reports. Chief Noffsinger noted that there was an active Strike Team on the Park Fire. Vice President K. Watkins III question regarding the administrative rate, Chief Noffsinger noted that the CalOES Admin rate was updated to .24 for FY 24-25.
